- 7. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the affiliations & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examinations bye laws, directions issued from time to time and the law of the land.

- 8. That the school will ensure compliance of a statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and statutory requirements like EPF, ESI and Labour
- 9. That the school will ensure that Building safety, Fire Safety, water Safety Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time as per the prescribed term.
- 10. That the school will ensure that all required infrastructure is available with the school before stating classes.
- 11. That the school will ensure that sufficient number of qualified teacher as per the provision contained in affiliation bye-laws are available with the school before starting classes.

- 16. That the school will not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has complied will all the condition imposed by CBSE and the post affiliation conditions contained in affiliations by laws along with general rules.
